#### WOMEN'S TOURNAMENT RULES

#### TEAM CAPTAIN: PLEASE RETAIN FOR YOUR INFORMATION

- 1) The Panama City Women's Tournament is conducted under the authority of and certified by the United States Bowling Congress and all applicable USBC Rules will govern this tournament. Competition is restricted to **female** members of Panama City USBC only.
- 2) The tournament will consist of OPTIONAL Team, Doubles, Singles, and all events. You may partake in all events listed, or just one event if you choose. Multiple participation is allowed. You can only cash once in singles.
- 3) Bowlers must provide their Photo ID along with their current USBC ID. If current membership cannot be verified, a USBC Associate membership card must be purchased at the tournament site.
- 4) Entering Average:
  - A. 2024-25 highest USBC winter league average of 21 or more games;
  - B. If NO winter average, then summer 2025 average of 21 or more games;
  - C. If NO 2024-25 winter or 2025 summer average, use highest current season USBC average as of the start of the tournament;
  - D. Bowlers with none of the above averages must bowl scratch

It is each bowler's responsibility to verify the accuracy of their own average whether originally submitted by the bowler, the team captain or others. Failure to use the correct average may disqualify the score if submitted average is lower than correct average, thereby resulting in a lower classification or more handicap. Prize winnings will be based on the submitted average if it is higher than the correct average.

Tournament management reserves the right to re-rate any entrant prior to bowling. If the entrant refuses the re-rate entry fee will be refunded.

#### USBC Rule 319 DOES APPLY. All averages are subject to further verification by the Tournament Director.

- 4) TOURNAMENT HANDICAP IS 100% OF 200.
- 5) a) All prize money will be returned 100% at the ratio of 1 in 5 for team, doubles, and singles and 1 in 8 for all events.
  - b) Plaques will be awarded to the winning team, doubles partners, singles, and all events in all divisions.
  - c) In the event of a tie for first place in any event, co-champions will be declared. Equal awards will be given.
- 6) All entrants are automatically eligible for all events awards if they bowl team, doubles, and singles. To be eligible for the **cash** awards of the All Events an additional entry fee must accompany the entry form. Paid all events are not transferable unless the substitute replaces the original entrant in all three events and the transfer is made by the tournament director or other. PC USBC official prior to the time of the substitute's participation in any event.
- 7) After entries have been received and dates assigned by the Assn. Manager or Tournament Director, no fees shall be refunded.
- 8) No changes will be made in the entrant's scheduled time except in case of an emergency and any change must be approved by the Assn. Mgr., Tournament Director.
- 9) Individuals who are members of bowling organizations identified as "professional" are eligible for participation; however, two professional bowlers may compete on a team and one professional on a doubles team.
- 10) Team captains and substitutions must report to the tournament office at least 30 minutes prior to the scheduled squad time.
- 11) If your entry is doubling with another entry, BOTH entries must be submitted at the same time and mailed to the address on the entry form or sent by e-mail to the e-mail address on the entry form.

DRESS CODE: Bowlers must wear a half-sleeve shirt, casual slacks, and/or jeans in good condition. Any shorts, skirts, skorts must be longer than your fingertips when placed by your side. During participation, bowlers are NOT permitted to wear headgear, or sweats. (Ear buds are permitted) All clothing must be neat, clean and in good condition. Violators may NOT be allowed to participate in that event. Tournament management reserves the right to make all final decisions on dress code.

Tournament Director reserves the right to add additional shifts or extend the entry deadline as deemed necessary
